## **REVIEW OF PSA SAFETY INFRINGEMENTS**

As part of our ongoing commitment to enhance the safety of all port users, we are implementing measures to improve responsible driving within the container terminal facilities, and encouraging safer behaviour in wearing of Personal Protective Equipment (PPE). These measures include increasing demerit points and revising enforcement charges for speeding and PPE-related offences. Such offences can potentially result in very serious consequences:

2 The table below reflects updates to the enhanced penalties for speeding offences:

S/n	Rules			
1.	Exceeding speed limit by 1 to 10 km/hr in areas other than wharves			
2.	Exceeding speed limit by 11 to 20 km/hr in areas other than wharves			
3.	Exceeding speed limit by 21 to 30 km/hr in areas other than wharves			
4.	Exceeding speed limit by 30 km/hr in areas other than wharves			
5.	Exceeding speed limit in the wharves (Chassis lanes and backreach) by 1 to 10km/hr	ST05		
6.	Exceeding speed limit in the wharves (Chassis lanes and backreach) by 10km/hr	VT07
