To: All Port Users

**ENHANCED PENALTIES FOR POSSESSION, DISTRIBUTION OF E-VAPORISERS**

With effect from 1 September 2025, enhanced penalties for the possession or distribution of E-Vaporisers will apply under the Tobacco (Control of Advertisements and Sale) Act. Please refer to Annex A.

PSA will apply the following revised penalties to all port users.

- Individuals found possessing or involved in distribution of E-Vaporisers will be evicted from PSA's restricted areas, and respective PSA pass and vehicle permit will be revoked for a minimum of 1 year ban.
- The case will be referred to the relevant government agencies for enforcement actions.

All individuals are to comply strictly with the stipulated regulations.

Importers, sellers and distributors of etomidate e-vaporisers will face up to 20 years' imprisonment and 15 strokes of the cane.

## **1<sup>ST</sup> OFFENCE**

- Seizure of vapes
- Composition fine

## **REPEATED OFFENDERS**

**Short-Term Visit Pass:**

- Banned from re-entry into Singapore

**Long-Term Visit Pass/Work passes,  
Student/Dependant passes:**

- Seizure of vapes and composition fine
- Pass revoked, deported and banned from re-entry into Singapore on 3rd offence

### **Foreigners Using Etomidate Vaporisers (or test positive for etomidate)**

- Pass revoked
- Deported and banned from re-entry into Singapore
